He was elected a Fellow of the Nautical Institute in 2009 and Vice President in 2017. Following on from a research degree completed in 2009, André wrote the book Mentoring at Sea – The 10 minute challenge, which was published by The Nautical Institute in 2012.

He is currently in full time employment as a Mooring Master in the lightering trade, undertaking ship-to-ship transfers in the Gulf of Mexico, offshore the US East Coast, Uruguay & Brazil, having decided to return to sea in the summer of 2012 after over eight years ashore, working as a marine consultant in Houston, Texas.
